On June 3, 2019, the city council for the City of Bandon met for their monthly city council meeting in Bandon, Coos County, Oregon wherein the Council agreed and voted to increase the rates charged for water and wastewater utility services, according to Resolution No. 19-08 Amending the Water Rate Schedule, *Exhibit 1*, and Resolution 19-09 Amending the Wastewater Utility Rate Schedule, *Exhibit 2*, notwithstanding the Charter prohibitions on fee increases without the consent of the City voters.

## FIRST CLAIM FOR RELIEF (Declaratory Judgment)

8.

Plaintiff refers to Paragraphs 1-7 above and incorporate them by reference as though fully set forth herein.

9.

An actual controversy has arisen and now exists between Plaintiff and Defendant concerning whether Defendant has authority to increase the rate for water and wastewater utility.

10.

The City of Bandon misused their authority by basing their decision to increase the rates for water and wastewater utility on a request by the Bandon Utilities

Commission. However, the Utilities Commission does not have the power to declare an emergency and neither is there grounds for official declaration of emergency under the Bandon City Municipal Code 1.06.020 that would justify a water and sewer rate increase in violation of Sections 46-48 of the City Charter.

11.

The Utilities Commission's defined the emergency as a "projected venue shortfall." This is not an emergency according to the City of Bandon Municipal Ordinance 1.06.010(A).

12.

The decision to increase the utility rates for water and wastewater utility is void because it violates with the City of Bandon Charter at Sections 46 and 47.

13.

Plaintiff seeks a declaration by the Court that the City Council of Bandon cannot increase the rates for water and wastewater utility without consent by the voters and that Resolutions 19-08 and 19-09 must be declared void as a matter of law.

14.

Plaintiff has no adequate remedy at law.

15.

Plaintiff may be entitled to reasonable costs, attorney fees and disbursements against Defendant according to ORS 20.105.

WHEREFORE, Plaintiff prays for judgment as follows:

- Declaring that Plaintiff seeks a declaration by the Court that the City Council
  of Bandon cannot increase the rates for water and wastewater utility without
  consent by the voters;
- b. Declaring that Resolutions 19-08 and 19-09 are void as a matter of law.
- Awarding Plaintiff its reasonable costs, attorney fees and disbursements against Defendant incurred herein according to ORS 20.105 and
