Dear Oregon Government Ethics Commission Representative,

I am presenting this formal complaint to the Oregon Ethics Commission on behalf of the citizens of the City of North Bend in accordance with Oregon Revised Statute (ORS) 244. This complaint is filed against Ms. Stephanie Wilson who is currently employed by the City of North Bend and holds the assigned title of "Main Street Manager" (Exhibit 1). It is alleged that as a public employee of the City of North Bend, Ms. Wilson has breached the Oregon ethics law on multiple occasions by failing to publicly disclose the nature of her actual and potential conflict of interest as the owner of Painted Zebra Designs LLC and operating as Painted Zebra Boutique (Exhibit 2). Ms. Wilson is listed by the Oregon Corporation Division as the sole manager/owner of the business located at 1997 Sherman Ave. in North Bend, Oregon. The store front of this business is located within the jurisdiction of assigned responsibility of her Main Street Manager position. Additionally, it is alleged that Ms. Wilson's ongoing employment as the Main Street Manager by the City of North Bend has already and may result in continuing actual and potential financial benefit to her business and by extension directly to Ms. Wilson.

The basis of the formal complaint stems from several violations of the Oregon Ethics Law over the course of Ms. Wilson's employment with the city beginning in July of 2022. The first alleged breach of ethical conduct occurred at a public work session/meeting of the city's Urban Renewal Agency (URA) conducted on June 13, 2022. Ms. Wilson spoke to the City Council/URA members regarding her hiring as the city's Main Street Manager at 40 minutes and 25 seconds and at the 1 hour and 23<sup>rd</sup> minute of the meeting (Exhibit 3). Additionally, in the second portion of her testimony to the City Council on July 13th, Ms. Wilson makes a recommendation on the expenditure of taxpayer funds to the council that has a clear indirect financial benefit to her business. In neither instance during Ms. Wilson's testimony in this public meeting was the required disclosure read into the public record as required by ORS 244.130(1).

The second alleged breach of ethical conduct occurred at a public meeting of the North Bend Main Street Board held on July 12, 2022. The meeting minutes are enclosed as Exhibit 4 and are also available on the city website at Agenda Center - North Bend OR (northbendoregon.us). As shown, the meeting minutes fail to reflect that any public disclosure was ever read or entered into the public record regarding Ms. Wilson's ownership of her business and no statement of her actual or potential conflicts of interest in accordance with ORS 244.130(1) was acknowledged. A subsequent meeting was held on September 12th; however, the City Recorder has likely not yet transcribed the meeting minutes for public review as of this date and subsequent violations may have transpired but cannot be confirmed.

The third alleged breach of ethical conduct occurred on or before September 9<sup>th</sup>, 2022, regarding the sponsorship and promotion of the city's recent "Sip & Stroll" event. This event was promoted and coordinated directly by Ms. Wilson as the "Main Street Manager" with 22 local businesses listed as direct beneficiaries of the event. One of the 22 businesses listed was Ms. Wilson's own Painted Zebra Boutique Aka Painted Zebra Designs LLC. The city details the event on their web page located at Sip 'N Stroll (northbendoregon.us) (Exhibit 5). As described, patrons were asked for a "suggested donation" of \$10 per glass. The North Bend Main Street Facebook page states that these "donated funds will go towards projects and events the whole community can enjoy, downtown North Bend." Additionally, city staff were thanked on the Facebook page by Ms. Wilson for set-up of a tent and tree trimming in the surrounding area for the event whose sole purpose was to promote North Bend Main Street businesses including Ms. Wilson's own Painted Zebra Boutique. In this instance, taxpayer funds were directly expended for the actual and potential benefit of Ms. Wilson's own business. Funds which are effectively under her control as the Main Street Manager.

Although only having been an employee of the City of North Bend since July 2022, Ms. Wilson knew or should have known what her responsibilities were regarding the Oregon Revised Statutes as they pertain directly to her role as a designated public employee. Moreover, public disclosure of a conflict of interest – whether actual or potential - is a core individual responsibility that is necessary to ensure that those who have been entrusted with the affairs of government are acting honestly, faithfully and competently in performance of their duties as a public employee. We believe that the evidence conclusively shows that this high standard has not been met by Ms. Wilson or the City of North Bend who clearly know that her employment in this position represents a definitive ongoing conflict of interest.

I believe it is extremely unfortunate that I must now call on the Oregon Ethics Commission to intervene with the City of North Bend to ensure that the ethics laws of the state of Oregon are upheld for the benefit of every citizen of the City of North Bend. However, I strongly believe that the integrity and public trust of a critically important governmental process is at stake that requires investigation of this complaint. We greatly appreciate your expeditious review of this matter along with the documents submitted in support the complaint. If I can be of further assistance, please contact me at your convenience.



Stephanie Wilson has been hired as North Bend's Main Street manager. She will be responsible for working with downtown merchants, property owners and other stakeholders to continue the downtown revitalization and renaissance while collaborating to enhance economic vitality through sustainable tourism and urban renewal.

Downtown North Bend is an economic generator for the city and the communi manager, Wilson will be responsible for collaboratively working with economic and urban renewal partners to further the City Council's goal of supporting, su



economic vitality for local businesses.

The Main Street program helps sharpen existing business owners' competitiveness, helps foster entrepreneurial start-ups and expansions, and recruits compatible new businesses and new economic uses to build a commercial district, create jobs and respond to consumers.

Wilson will work with the City Council to appoint a Main Street Board dedicated to serving the central downtown business district and supporting the local community.

The board of directors will then be tasked with developing and executing a Main Street Work Plan, fundraising and grant opportunities, and downtown projects and events.

Wilson is a North Bend High School graduate and attended Southwestern Oregon Community College. She has won the "Best of the South Coast Woman's Boutique" award for the past 10 years running. She was also a national winner in the first annual Microsoft Small Business video contest. In 2009, she opened Painted Zebra in the historic Odd Fellows Building in downtown North Bend during the great recession.

North Bend's participation in the Oregon Main Street Network gave it access to the Oregon Main Street Revitalization Grant program, which funds building improvement projects that spur economic development.

North Bend is among 28 Oregon Main Street Network organizations to receive matching grants for building projects that encourage economic revitalization in central downtown business districts across the state.
