Hi,

My life is so woefully dismal that I eagerly open your attachments. Also, I am so obsessive that I am working on refining the newsletter to eliminate all of the sugar coating.

I've read the proposed resolution through twice and I think it covers the problem.

The lower figures Robert gave us for the Water and the Sewer shortfalls are here. I suspect that's because the language of the resolution accounts for the higher figures Robert gave to the Utilities Commission and not the Council or Budget Committee.

I eagerly await your tale of City interaction. See, I told you my life is dismal.

I'm providing some background points, merely because they are background points; I'm an historian; I need to use my notes for something. On 2/10/16, we were informed by C. Good, that our expenditures are outpacing our revenues. The Commission discussed how we wanted to approach the utility rate issue and agreed that maintenance must be done on an ongoing basis. This is when the Commission agreed that we were not going to put rate setting on the November. ballot (in response to Bob Berry's question regarding same). We agreed that we need to increase the base rate. The Chair of the Utilities Commission, you, said that we need a cost of service study, which we haven't gotten to this day, 4/10/19.

At the Utilities Commission meeting on 3/16/16, Chris Good addressed closing the gap in the water fund. Figures given were: \$360,000 out of capital funding for seismic retrofit and filter/media, regular operations. We'd still have a deficit of \$100-600K. Proposals were made, Increase in rates, 54%, Emergency power generator at the water plant.

At the 3/30/16 meeting we worked under the stated premise: "Utilities are a business, fees support the business lust like any business." We proposed a minimal amount of water rate raise. \$10/month residential, \$20/month commercial. This will pay for maintenance and damage control but is not enough to, build up a reserve account. We need to maintain what we have.

At the 5/11/16 meeting, we figured out how to publicize the rate increases and said we would tell the people exactly what we are doing. 4 projects identified: filter/media; chlorine generator; seismic valve; refurbishing 2million gallon water tank. Additional mentions of back up pumps/generators. Daniel Graham asked, "If this doesn't pass, then what?" Answer: "Transfer \$ from the General Fund and from other areas."

In 2016, all of he meetings above included detailed discussion of the proposed reservoir.

As far as the other items related to the lack of accountability in the 941 Fund, intentional restriction of public information, intentionally not informing the Commission of the problems, and requesting an outside audit, those may best be subjects addressed in a different venue. I was trying to use this Resolution in an effort to fix the problems with the proposed budget. If you feel strongly that they should be included in this Resolution, I'm not sure the best and most appropriate way to do that, so perhaps you can suggest some language to be added.

I believe the utility shortfalls are essentially the result of not having adequate revenues to cover the costs to operate and maintain aging facilities, which I had predicted in my Budget Messages for many years prior to my retirement in 2014. I would then anticipate that the City Council would put the matter on the June agenda as an action item, including declaring and emergency and adopting the emergency rate increases to be effective for all water sold after July 1. The word will certainly get out through the newspaper and your column, which I suggest happen after the Utilities Commission makes its recommendation on Monday night. That way, people will have plenty of notice to show up at the June Council meeting, do their Facebook postings, and grumble and grouse at the City Council during the June meeting, as part of your consideration of whether to go with the Utilities Commission recommendation and declare emergency and raise the rates.

As for a Town Hall meeting, that needs to happen sometime after the rates have been increased. I carefully read the City Manager's newsletter and the city's utility newsletters, (both of which we greatly appreciate), and didn't catch there was such a massive deficit. But, I think the City would get much more support especially if it has to go to a vote if people knew how such deficits happen. I know the utility company newsletter has been very good about explaining where the money we voted for has been used and what is further needed and think such information would help get the public's support for an increase if the City explained how such large deficits occurred when there are so many new houses being built and going onto the city's utilities.

Thanks Mona. the deficits have occurred because the city is not able to raise utility rates because of a charter amendment. When the charter amendment first went into effect, there were pre-existing agreements with the state, which allowed us to raise rates, but those debts have now been paid off and we have not been able to raise rates for some years, except for the \$10 increase for capital water projects which the voters approved last year, which has resulted in a big deficit. Water, sewer and electric are enterprise funds, which need to pay for themselves, but without being able to raise rates in our utilities, that has not been possible. We have been putting this off for several years, by being as frugal as possible, but the time has come that these very modest rate increases are necessary. Had we, like every other city in the state and pretty much the country, been able to keep pace with our utilities, we would be fine, but that has not been the case. I hope you read my column, which clearly shows what others in our area are paying for the same amount of water.

Not only that, and I do not mention it in my column, but our general property tax rate is 46 cents a thousand; others in the county range from \$6 to \$8 a thousand.

Not only are we in a deficit position in operating both the water and the sewer departments, but our sewage treatment plant is nearing the end of its 20-year life. we have very dedicated people in both departments, including our electric (where we were able to balance that budget without a deficit), but they can only do so much.

I will send you a copy of what I wrote for my column in case you did not see it.

And yes, thank God, we are growing because not only do they pay much-needed Systems Development Charges, which go toward capital projects, but they also hook up to our utilities.

The City Manager projects that next year, without a rate increase, the Sewer Fund will have revenues of \$838,197, but expenditures of \$1,060,197, leaving a deficit of \$222,000. The emergency rate increase is projected to raise the necessary \$222,000.

- MW On your latest utility bill (dated 7/31/19) how many gallons of water did you use, and what were your water and sewer bills? Neither Mary O'Dea nor I can make ours calculate to the amount we were billed, no matter whether we use the old rates, the new rates adopted on 7/3/19, or a hybrid of the two which I thought was being used during this transition month. Maybe you could help straighten us out before we make fools of ourselves?
- MS Because I watered constantly I used 5000 gallons of water for \$32.02 the sewer was \$36.03 and the utility tax was \$12.35.
